
BRIEF on VOICE






By building a broader constituency of alternative voices to the mainstream development discourse through research and public education, VOICE takes a stand against unjust and undemocratic practices.

Climate change under neoliberal capitalism

There is little doubt that climate change is happening. As countries and international organisations ponder over how resolve an impending crisis brought about by global warming, they should also stop to consider whether the prevailing market oriented economy makes enough of an allowance to arrive at sustainable and aenuine measures to contain this impending crisis.

The consequences of climate change already threaten the planet and communities around the world. However, strong resistance is present among the northern as well as southern communities to change the existing system of over consumption and exploitative nature of the alobal transnational corporations and international financial institutions. Although it is the North that is mainly responsible for carbon emission and destruction of nature and socioeconomic condition the Southern elites cannot avoid the responsibility either. It is also clear that the southern elite show little willingness to take proper measures against pollution and destruction by corporations often backed by the international financial institutions. Rather, it is observed that these institutions and corporations undermine government policies undertake activities that cause enormous damage to the nature and people's livelihoods.

Martin Khor of the Third World Network points out that the global reduction of 80 per cent greenhouse gas emissions from 1990 levels by 2050, that many consider necessary, will have to translate into reductions of at least 150 to 200 per cent on the part of the global North if the two principles-'common but differentiated responsibility' and recognition of the right to development of the South-are to be followed. But are the governments and peoples of the North prepared to make such commitments?





Introduction

The IFIs sit at the heart of the global aid architecture. The World Bank is a major source of finance for developing countries and the IME has a crucial function in "signaling" which countries receive more funding from both official and private sources. These roles confer incredible power to these two institutions that have spread their wings well beyond their original mandates. The governance of the World Bank and IMF is severely skewed towards rich countries that dominate decision-making in these institutions.

The World Bank (WB). International Monetary Fund (IMF), Asian Development Bank (ADB) and other donor agencies have, for the past few decades, provided

capitalism, exerting a heavy influence on global trade policies that mainly promote trade liberalization and public sector privatization. Many of the least developed countries (LDCs) have become a place of experimentation for trade liberalization at the hands of international financial institutions (IFIs) who pressure the government into liberalizing trade policies. This causes serious devastation in public service sectors including heath, education, water, agriculture and food.

Despite the movement for democratization across the developing world. International Financial Institutions (IFIs) have been continuing to bypass parliaments, a trend that is at odds with donor insistence on 'good governance.' The WB, IMF and Regional Development banks attach

"International Campaign on Climate Refugees' Rights" Demanded New Legal Institutional Framework at Durban UN Talks

[Durban, 6 December 2011] Speakers in a public dialogue said that climate change catastrophe not only pose a mortal danger but also lead to the destruction of the means of livelihood which threaten millions of people in the global south to become refugees. Recent studies show that around 30 million people from the coastal areas of Bangladesh, 300 thousand from the Maldives, 10 million from Vietnam, 10 million from Mediterranean Egypt, and 600 thousand from Guyana will be displaced due to loss of land as a result of climate change effects.

The public dialogue organized by the International Campaign on Climate Refugees' Rights (ICCR) was held at the University of KwaZulu-Natal today while the civil society groups urged the global leaders to form legal framework for the displaced victims-climate refugee.

Ahmed Swapan Mahmud, convenor of the Campaign said "a legal safeguard protocol should be in place to ensure the political, social, cultural and economic rights of the climate refugees by the international community presently meeting under the Conference of Parties (COP-17) here in Durban, South Africa".

Experts and rights activists on Friday demanded a people-centred post 2015 development framework to ensure meaningful participation of all concerned stakeholders.

They urged the concerned authorities to adopt a strong, inclusive and legitimate post 2015 framework to succeed in the Millennium Development Goals, said a press release.

The speakers were present at a conference tilted 'A Transformative Post 2015 Development Agenda: Citizens' Demands and Expectations' held at the Dhaka Reporters Unity auditorium, Jointly organised by rights groups VOICE and Beyond 2015. In the upcoming 69th United Nations General Assembly 2014, United Nations is going to prepare a new sustainable development framework with its member states as the Millennium Development Goal will end in 2015.


